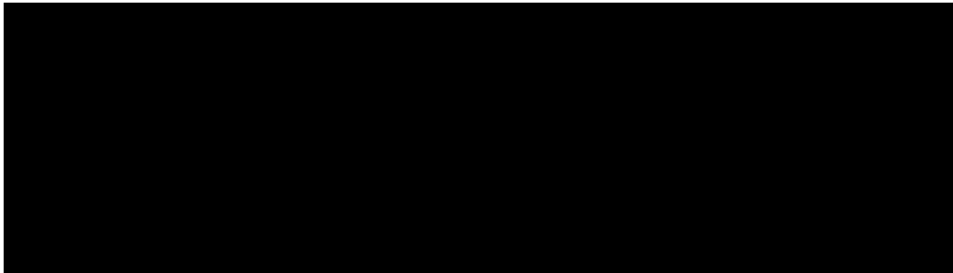

MARGIN
